



Terms and Conditions



This document sets out the terms of participation in the MooMoney competition (the "Competition").

The promoter of this Competition is Dynamic Mobile Solutions (the "Promoter") and Dynamic Mobile Solutions (the "Aggregator")

1. Entry to the Competition is open to all residents in Namibia. An entrant must be an individual and not a company or organization.
2. The Promoter requires positive identification upon collection of Prize.
3. Employees of the Promoter and Aggregator or any person associated with the Competition and any organization or individual associated with the provision of the prize(s), are not eligible to enter.
4. By entering the Competition, each entrant agrees to be bound by these Terms and Conditions. The Promoter may in its discretion refuse to award any prize to any entrant who fails to comply with these Terms and Conditions.
5. Entry into the Competition is N\$3.00, excluding VAT, via SMS. Short code 22022.
6. The Competition opens at 00.01 am on 1 October 2015 and closes at 24:00PM on 31 October 2015 ("Competition Period"). Any entry received after the expiry of the Competition Period will be deemed invalid. No responsibility is accepted for late, lost, delayed or misdirected entries.
7. To enter the Competition, you must: send an SMS to 22022. All entries are valid, regardless of the SMS message.
8. While you may enter the Competition more than once, you cannot win more than one prize.
9. Prizes in the competition will be N\$ 31,000 cash and 31 x N\$250.00 airtime vouchers.
10. The Prize Winner must be available to redeem the prize within one week after the closing date as stipulated by the Promoter. If the Prize Winner is not able to redeem the prize by that date, the Promoter may determine another prizewinner at its discretion. Should the main prize winner be younger than 18 years, the prize will be handed over to the legal guardian.
11. No component of the prize can be transferred or redeemed for cash. In the event that any of the prizes become unavailable due to circumstances beyond the Promoter's control, the Promoter reserves the right to provide a similar product to the same or greater value as the original prize, subject to any applicable laws or written directions made under applicable legislation.
12. You agree that the Promoter may use your entry/name provided to the Promoter for any promotional and marketing purposes of the Promoter without notice.
13. Decisions of the Promoter and Aggregator are final and will be binding on each person who enters the Competition and no correspondence will be entered into.

If there is any event that prevents or hinders the Promoter's conduct of the Competition or the Promoter's ability to deliver the prize/s to the prize winner/s of the Competition, the Promoter may, in its discretion, cancel the Competition and recommence it at another time under the same conditions or select another winner.

Neither the Promoter nor the Aggregator is responsible for any incorrect or inaccurate information, or for any of the equipment or programming associated with or utilized in this Competition, or for any technical error that may occur in the course of the administration of this Competition. The Promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to or alteration of entries.

To the full extent permitted by the law, the Promoter and/or the Aggregator will not be liable for any injury, damages, expenses, or loss whatsoever (whether direct or inconsequential) to persons or property as a result of any person entering into the Competition or accepting or using any prize, including without limitation non-receipt of any prize or damage to any prize in transit and the Major Prize Winner's failure to comply with the terms and conditions (if any) specified by any third party in relation to licenses as applicable.
